Information We Collect and How We Use It

We offer a number of Services that do not require you to register for an account or provide any personal information to us, such as reviewing our upcoming and past auctions. In order to provide our full range of Services, we may collect the following types of information:

- Information you provide When you sign up for an account with Palatium Auctions® or other Palatium Auctions® service or promotion for Services that require registration, we ask you for personal information (such as your name, email address and an account password). For certain Services, such as bidding in auctions, we also request credit card or other payment account information which we maintain in encrypted form on secure servers. We may combine the information you submit under your account with information from other Services or third parties in order to provide you with a better experience and to improve the quality of our Services.
- Cookies When you visit Palatium Auction®'s websites, we send one or more cookies a small file containing a string of characters to your computer or other device that uniquely identifies your browser. We use cookies to improve the quality of our Services, including for storing user preferences and tracking user trends. We may set one or more cookies in your browser when you visit a Palatium Auctions® website.
- **Log information** When you access the Services, our servers automatically record information that your browser sends whenever you visit a website. These server logs may include information such as your web request, Internet Protocol address, browser type, browser language, the date and time of your request and one or more cookies that may uniquely identify your browser.
- **User communications** When you send email or other communications to Palatium Auctions®, we may retain those communications in order to process your inquiries, respond to your requests and improve our Services.
- **Links** Palatium Auctions® may present links in a format that enables us to keep track of whether these links have been followed. We use this information to improve the quality of our Services, search technology, customized content and advertising.

Palatium Auctions® only processes personal information for the purposes described in this Privacy Policy. In addition to the above, such purposes include:

- Verifying your identity so that we can be sure that all of our communications with you are secure and confidential;
- Responding to inquiries or requests from you;
- Providing our Services, including the display of customized content;
- Communicating service updates, offers and promotions;
- Auditing, research and analysis in order to maintain, protect and improve our Services;
- Ensuring the technical functioning of our network;
- Protecting and enforcing the rights or property of Palatium Auctions® or our users, including our sellers;
- Protecting network integrity and security, ensuring quality control, optimizing capacity and preventing misuse;
- Network enhancement planning, engineering and technical support;
- Conducting research and analysis for maintaining, protecting and developing our network and our Services;
- Preventing illegal activities, suspected fraud, and potential threats to our network;
- Investigating violations of our Terms of Service or other service conditions or restrictions; and
- Developing new Services.

Palatium Auctions® processes personal information on our servers in the United States of America. In some cases, we process personal information on a server outside your own country. We may process personal information to provide our own Services.

Choices For Personal Information

When you sign up for Services that require registration, we ask you to provide personal information. If we use this information in a manner different than the purpose for which it was collected, then we will ask for your consent prior to such use. If we propose to use personal information for any purposes other than those described in this Privacy Policy, we will offer you an effective way to opt out of the use of personal information for those other

Most browsers are initially set up to accept cookies, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. However, some Services may not function properly if your cookies are

Information Sharing

- We have a good faith belief that access, use, preservation or disclosure of such information is reasonably necessary to (a) satisfy any applicable law, regulation, legal process or enforceable governmental request or if required by law, such as to comply with a court-ordered subpoena, for regulatory oversight or for other legal process, (b) enforce applicable website terms of use and auction terms and conditions, including investigation of potential violations thereof, (c) detect, prevent, or otherwise address fraud, security or technical issues, or (d) protect against harm to the rights, property or safety of Palatium Auctions®, its users or the public as required or permitted by law.

If Palatium Auctions® becomes involved in a merger, acquisition, or any form of sale of some or all of its assets, we will ensure the confidentiality of any personal information involved in such transactions and provide notice before personal information is transferred in a manner that would make it subject to a different privacy policy. We may share with third parties certain pieces of aggregated, non-personal information, such as the number of users who searched for a particular term, for example, or how many users clicked on a particular asset listing or other part of our sites. Such information does not identify you individually.
